OAAF CONTINUED TO PUSH CONGRESS TO MAKE ROBUST INVESTMENTS IN FOREIGN ASSISTANCE FUNDING AFTER THE DISMANTLING OF USAID AND CUTS TO FOREIGN AID, WHICH RESULTED IN CONGRESS ALLOCATING \$50B IN FUNDING FOR FOREIGN ASSISTANCE. OAAF HAS ENGAGED ON A SUITE OF TAX-RELATED LEGISLATION, ON ISSUES RANGING FROM TAXATION OF THE ULTRA-RICH AND STRENGTHENING CORPORATE TAX RATES AND ENFORCEMENT, WITH A FOCUS ON THE ONE BIG BEAUTIFUL BILL ACT'S RAMIFICATION FOR TAX FAIRNESS AND CUTS TO THE SOCIAL SAFETY NET.
